Business

25TP006 – Approve the Rapid City Area Metropolitan Planning Organization 2024 Traffic Volume Counts Report. The report provides the public and business community with traffic count data to help make informed decisions. Harrington reviewed the Traffic Counts Report.

Odden moved, Carlson seconded and motion carried unanimously to approve the Rapid City Area Metropolitan Planning Organization 2024 Traffic Volume Counts Report.

25TP007 – Approve the Section 5310 Award Recommendation Harrington reviewed the Section 5310 Award Recommendation noting the recommendation would be to award Black Hills Works \$85,000 and Prairie Hills Transit \$127,500. Discussion followed regarding the recommendations.

Dokken moved, Eick seconded and motion carried unanimously to approve the Section 5310 Award Recommendation.

25TP008 – Approve the 2025-2028 Transportation Improvement Program Amendment #25-004. Harrington reviewed the amendment noting it would add funding in the Transportation Alternative Projects category for two projects that were selected by the Transportation Commission for construction in 2027 and 2028. The two projects will work to improve the bike and pedestrian network within the City. Discussion ensued regarding the amendment.

Weitgreffe moved, Martin seconded and motion carried unanimously to approve the 2025-2028 Transportation Improvement Program Amendment #25-004.
